The group's operational principles are anchored within the founder's vision of a corporate entity unique in its respect for people, protection and care for the environment, and the society in which it operates.

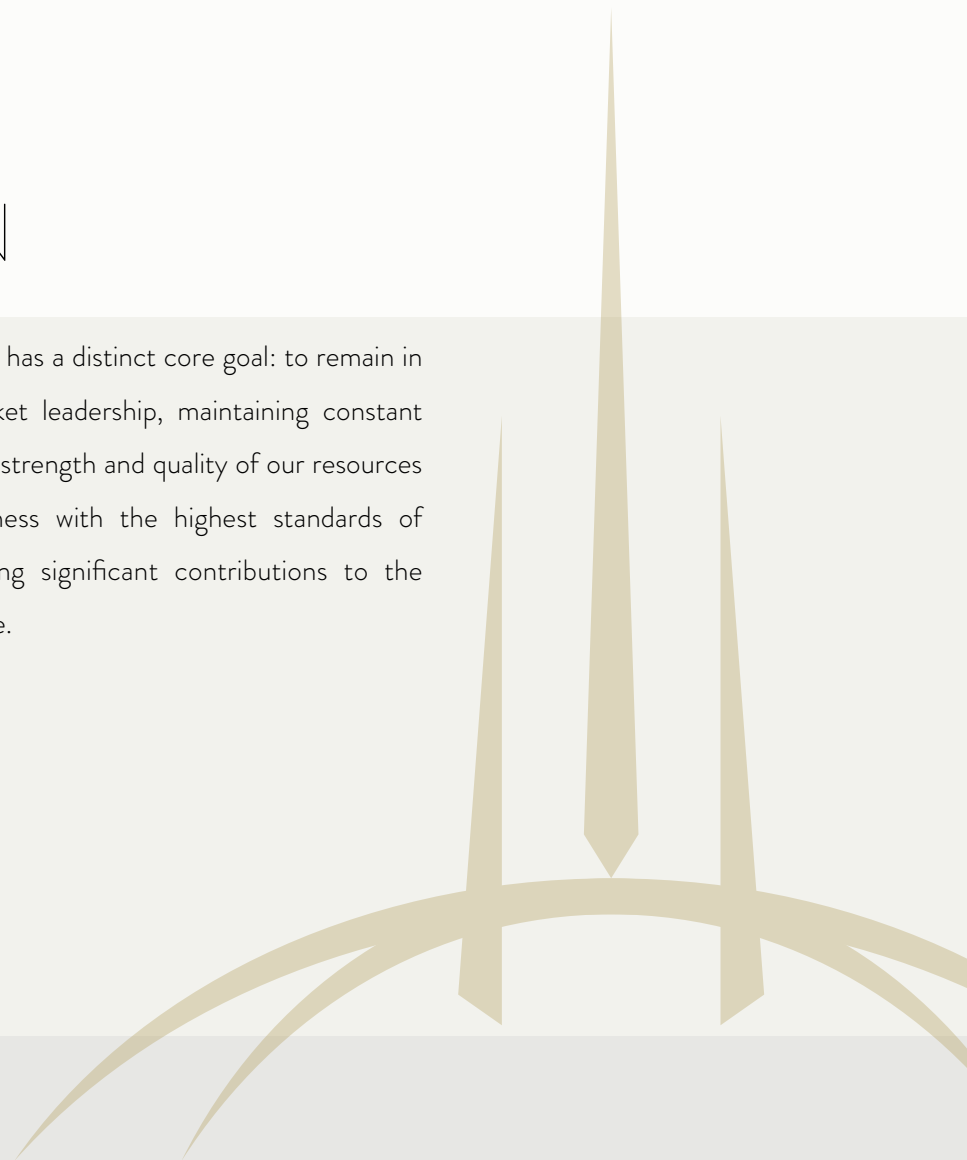

The Hashemite Group seeks to synergize its human, capital and technology assets to achieve maximized returns through the optimization of asset performance and personnel productivity.

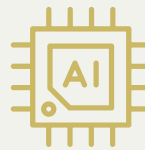

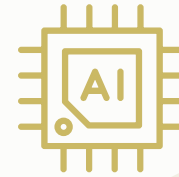
